DEVELOPMENT VARIANCE PERMIT DV 5A 20 - 3550 EAGLEVIEW DRIVE (MORGAN)

B. Chow, Rural Planner, provided an overview of the memorandum dated December 14, 2020 regarding Development Variance Permit DV 5A 20 - 3550 Eagleview Drive (Morgan) to increase the maximum permitted interior entryway and landing space from 2.8 square metres to 5.2 square metres in order to convert a single detached dwelling to a carriage house.
