PARTNERSHIP BETWEEN BLACK CREEK – OYSTER BAY FIRE PROTECTION SERVICE AND THE GREATER MERVILLE FIRE PROTECTION SERVICE

E. Grieve/B. Leigh: THAT the report dated August 28, 2018 regarding partnership between the Black Creek - Oyster Bay Fire Protection Service and the Greater Merville Fire Protection Service and a cost recovery formula to provide for training and supports associated with volunteer firefighters be received.
