**BYLAW NO. 553**

**A bylaw to update the Sandwich parcel tax from the one-time \$2000 charge in 2018 to an annual \$197 charge to achieve fairness through the Comox Valley Water Distribution Services Merger**

**WHEREAS** the Comox Valley Regional District (CVRD) adopted Bylaw No. 507 being “Sandwich Water Service Parcel Tax Bylaw No. 507, 2017” on January 23, 2018.

**AND WHEREAS** a regional district board is empowered by the *Local Government Act* (RSBC, 2015, c.1) to impose and levy a parcel tax to provide all or part of the funding for a service;

**AND WHEREAS** the Board desires to update the parcel tax for the Sandwich Water Service to raise funds for capital improvements, asset management and reserve contributions to the system and to achieve financial fairness by 2028 in conjunction with the Comox Valley Water Distribution Services Merger Project;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

**Amendment**

1. Bylaw No. 507 being “Sandwich Water Service Parcel Tax Bylaw No. 507, 2017” is hereby amended as follows:
  - a) By deleting subsections 1(a), 1(c) and 1(d) and replacing them with the following:
    - “(a) A parcel tax is imposed upon those parcels within the Sandwich water service area, which is established by Bylaw No. 506 being “Sandwich Water Service Establishment Bylaw No. 506, 2017” as amended from time to time.
    - (c) The annual parcel tax to be levied is \$197 per parcel and will be charged for five years beginning in 2019 and ending in 2028.
    - (d) The parcel tax is reduced to one charge of \$197 per folio each year in situations where a folio is made up of more than one parcel and the owner or a previous owner of the parcel has already paid towards the cost of the service for that year.”
  - b) By deleting Appendix A from the bylaw.
