A bylaw to amend the municipal ticket information bylaw to update the fines with respect to Electoral Areas Unightly Premises and Nuisances Regulations Bylaw

WHEREAS section 414 of the *Local Government Act* (RSBC, 2015, c. 1), and sections 264 and 265 of the *Community Charter* authorize the Comox Valley Regional District to enact a bylaw to allow the use of ticketing for enforcement offences;

AND WHEREAS the Comox Valley Regional District adopted Bylaw No. 104 being the “Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010” on April 27, 2010;

AND WHEREAS the board desires to update the fines associated with the violation of specific offenses;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1) Bylaw No. 104 being “Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010” is hereby amended by:

a) Replacing Schedule 3, which reads as follows:
