BYLAW NO. 525

A bylaw to amend the boundaries of the Comox Valley Water Local Service

WHEREAS Bylaw No. 1886 being the “Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996”, adopted on the 28th day of October 1996, established the Comox Valley water local service;

AND WHEREAS the board wishes to adjust the boundaries of the service to include the following property:

- ALL THAT PART OF TOWNSHIP 9, COMOX DISTRICT, BEING UNNUMBERED BUT SHOWN ON PLAN 552G AS LYING BETWEEN SECTION 10 ON THE WEST, SECTION 14 ON THE NORTH, LOT 160, COMOX DISTRICT ON THE SOUTH EAST AND LOT 192 ON THE SOUTH WEST.

AND WHEREAS the directors for Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands), Electoral Area ‘B’ (Lazo North) and Electoral Area ‘C’ (Puntledge – Black Creek) have consented to the adoption of this bylaw in writing;

AND WHEREAS this amendment is exempt from inspector of municipalities’ approval under regulation where the owner consents to the boundary amendment by petition;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1. Bylaw No. 1886 being “Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996” is hereby amended by:
 - (a) Including the property legally described as ALL THAT PART OF TOWNSHIP 9, COMOX DISTRICT, BEING UNNUMBERED BUT SHOWN ON PLAN 552G AS LYING BETWEEN SECTION 10 ON THE WEST, SECTION 14 ON THE NORTH, LOT 160, COMOX DISTRICT ON THE SOUTH EAST AND LOT 192 ON THE SOUTH WEST and as shown on the attached schedule “B” that forms part of this bylaw; and
 - (b) Repealing schedule “A” and replacing with the attached schedule “A”.

Boundaries

2. The boundaries of the Comox Valley water local service shall be as shown on the map attached schedule “A” that forms part of this bylaw.

Citation

This Bylaw No. 525 may be cited as the "Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996, Amendment No. 19."

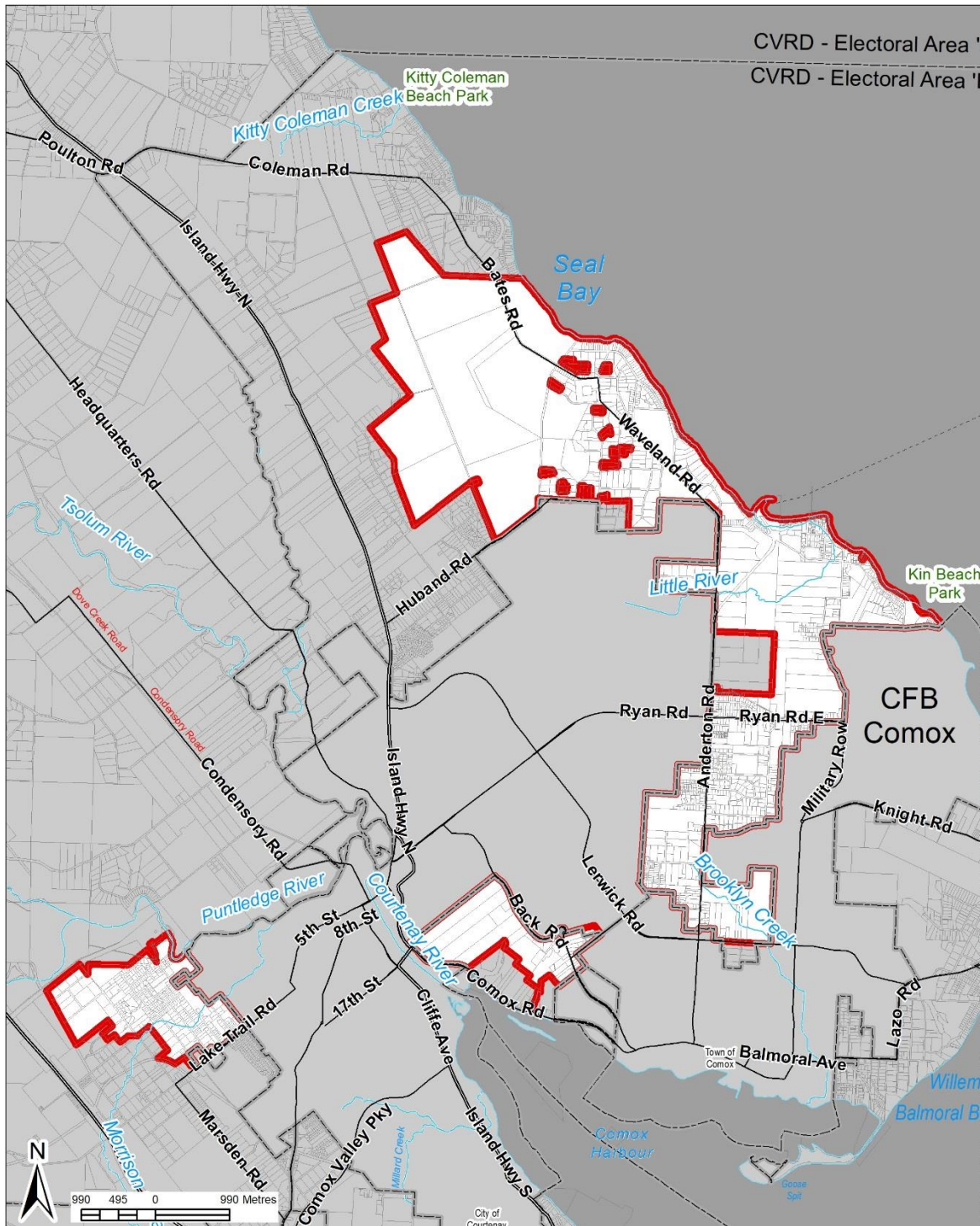

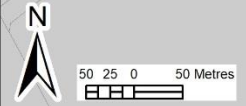
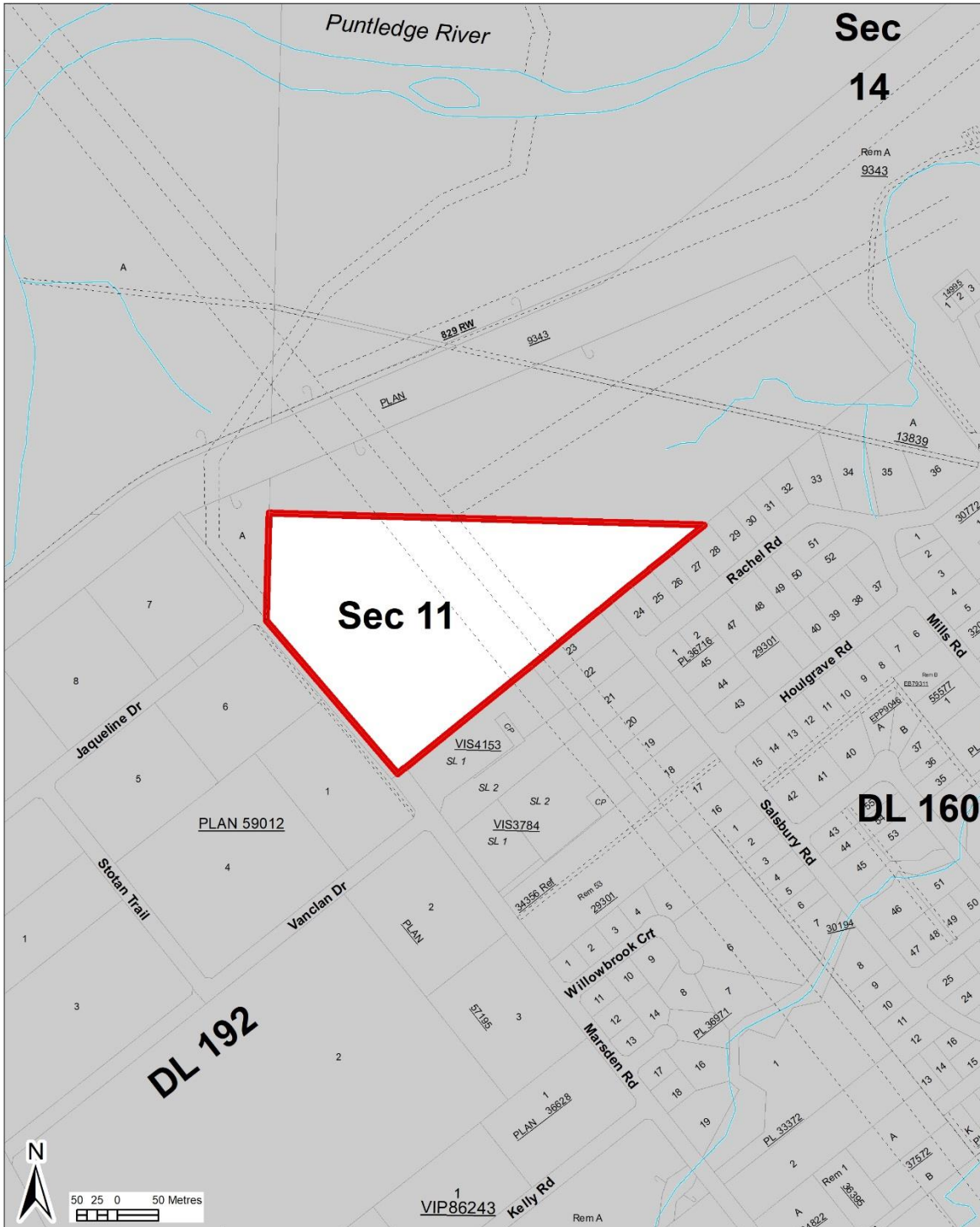
