#### Purpose

To provide information with respect to the 2022 parcel tax roll review panel and to appoint the directors to the panel for authentication of the roll.

#### Recommendation from the Chief Administrative Officer:

THAT a parcel tax roll review panel be held at 9:30 am on February 23, 2022 to authenticate the 2022 parcel and frontage tax roll and that the directors from Electoral Areas A, B, C and the extraterritorial Director for Electoral Area D, Strathcona Regional District with respect to the Black Creek/Oyster Bay water service area, be appointed to the panel.

#### **Executive Summary**

- Parcel taxes are levied in several local service areas in the Comox Valley Regional District (CVRD) in accordance with the applicable bylaws.
- As well as several service areas in the CVRD, the CVRD also levies parcel taxes in the Black Creek/Oyster Bay water local service area that has properties located in both the CVRD and Electoral Area D of the Strathcona Regional District.
- A parcel tax roll review panel, comprised of a minimum of three members, is a requirement of the Community Charter. Members are appointed each fall by Board resolution.
- The panel sits in February each year to provide an opportunity for residents to appeal their parcel tax assessment and to authenticate the parcel tax roll.
- The Province of BC collects the parcel taxes on behalf of the regional district by way of the annual property tax notice.

#### Background/Current Situation

The CVRD has several local service areas in which a bylaw has been adopted providing for the collection of a parcel or frontage tax to assist in the costs of providing the service.

Under section 388 (2) of the *Local Government Act* [RSBC 2015, c.1] (LGA), if a parcel tax is to be imposed, the Board must by bylaw provide for the preparation of a parcel tax roll for the service area, and for these purposes Division 4 [Parcel Taxes] of Part 7 of the Community Charter applies.

Section 204 of the Community Charter requires a parcel tax review panel to be formed to hear any complaints respecting the parcel tax roll and to authenticate the roll. Such a panel is therefore held each year by the end of February to consider and authenticate the roll prepared by CVRD staff.

Table 1 provides a list of the local service areas in which a parcel tax is levied by taxable frontage, taxable area or per parcel and the associated rates in effect at the time of this report. Adjustments to these rates may be recommended through the 2022-2026 financial planning process and would require a bylaw amendment, however is not anticipated at this time.

## **Intergovernmental Factors**

The CVRD levies a parcel tax by way of a frontage charge in the Black Creek Oyster Bay water local service area which has parcels located in both Electoral Area C of the CVRD and Electoral Area D of the Strathcona Regional District.

### **Citizen/Public Relations**

When a new parcel tax is levied, legislation requires that letters be sent to all impacted residents to ensure they are aware of the parcel tax assessment and their opportunity for appeal. This, combined with website information and a publicized notice in the local newspapers, ensures the public is informed about the parcel tax process. Copies of the rolls for the various service areas are published on the CVRD website as well as in hard copy which are available for viewing in the CVRD administration office.
