Purpose

The purpose of this report is to confirm the official assent voting results in respect of the Denman and Hornby Islands High-Speed Internet Project.

Executive Summary

- Assent voting (referendum) was conducted on November 27, 2021 to seek elector approval for the Denman and Hornby Islands High-Speed Internet Contribution Service Establishment Bylaw No. 672, 2021, the Denman and Hornby Islands High-Speed Internet Loan Authorization Bylaw No. 673, 2021 and the Denman and Hornby Islands High-Speed Internet Capital Contribution Agreement Authorization Bylaw No. 678.
- Following the Chief Election Officer's verification and determination, the official results of the assent voting are:

YES – 1,192 ballots cast (94%) NO – 81 ballots cast (6%)

- Given the results above elector approval for Bylaw No. 672, 673 and 678 has been obtained.
- The Board may now consider adoption of the above-noted bylaws.
