### COMOX VALLEY REGIONAL DISTRICT BYLAW NO. 500

#### A bylaw to amend Bylaw No. 142 being the "Comox Valley Regional District Building Bylaw No. 142, 2010"

**WHEREAS** Bylaw No. 142 being "Comox Valley Regional District Building Bylaw No. 142, 2010" was adopted on October 25, 2011;

**AND WHEREAS** Section 397 of the *Local Government Act* (RSBC, 2015, c. 1) authorizes the Comox Valley Regional District to impose fees for regional district's services; and the regional district can set different rates, can outline conditions for payment, including fee waivers, refunds, discounts and penalties;

**AND WHEREAS** the building permit fees have not been reviewed since 2003, and therefore, have not been updated to account for inflation and alignment with member municipalities;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

(h) Replacing Section 28(8) (Penalties and enforcement) as follows:

"Every person who commences work requiring a *permit* without first obtaining such a *permit* shall, pay an additional charge equal to 50 per cent of the permit fee prescribed in table 20.2 prior to obtaining the required *permit*."

with the following:

Every person who commences work requiring a *permit* without first obtaining such a *permit* shall, pay an additional charge of \$275 or 50 per cent of the permit fee, whichever amount is greater, as prescribed in table 20.2 prior to obtaining the required *permit*.
