## **BYLAW NO. 691**

## A bylaw to amend the Comox Valley Regional District Elected Officials, Directors, Officers and Employees Indemnification Bylaw to update the fire protection service areas in Section 1

**WHEREAS** the Comox Valley Regional District adopted Bylaw No. 237 being the "Comox Valley Regional District Elected Officials, Directors, Officers and Employees Indemnification Bylaw No. 237" on November 27, 2012;

**AND WHEREAS** the board desires to update the bylaw by adding fire protection services areas to Section 1(a)(vii) and other minor administrative updates to Section 1;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

#### Amendment

- 1. Bylaw No. 237 being "Comox Valley Regional District Elected Officials, Directors, Officers and Employees Indemnification Bylaw No. 237" is hereby amended by:
  - a) Replacing Section 1(a)(i) to 1(a)(vii) Interpretation, which reads as follows:
    - 1. In this bylaw:
      - (a) the words "directors", "officers" and "employees" include, but are not limited to:
        - (i) members of the regional district board of variance;
        - (ii) members of an electoral area advisory planning commission;
        - (iii) regional district election officers;
        - (iv) alternate directors;
        - (v) members of the Comox Valley sewage commission;
        - (vi) members of the Comox Valley sports centre commission;
        - (vii) volunteer firefighters providing firefighting services for any of the following:
          - 1) Oyster Bay Black Creek fire protection service;
          - 2) Denman Island Fire Protection service;
          - 3) Hornby Island Fire Protection service;
          - 4) Fanny Bay fire protection service

with the following:

- 1. In this bylaw:
  - (b) the words "directors", "officers" and "employees" include, but are not limited to:
    - (i) members of the regional district Board of Variance;
    - (ii) members of an Electoral Area Advisory Planning Commission;
    - (iii) regional district election officers;

- (iv) alternate directors;
- (v) members of the Comox Valley Sewage Commission;
- (vi) members of the Comox Valley Recreation Commission;
- (vii) volunteer firefighters providing firefighting services for any of the following:
  - 1) Black Creek Oyster Bay fire protection service;
  - 2) Greater Merville fire protection service;
  - 3) Mount Washington resort community fire protection service
  - 4) Denman Island fire protection service;
  - 5) Hornby Island fire protection service;
  - 6) Fanny Bay fire protection service
  - 7) Union Bay fire protection service
