A bylaw to amend Comox Valley Water Supply System Bulk Water Rates Bylaw No. 190, 2011 to amend the bulk water rates

WHEREAS Bylaw No. 190 being “Comox Valley Water Supply System Bulk Water Rates Bylaw No. 190, 2011” is a bylaw of the Comox Valley Regional District and was adopted on October 25, 2011;

AND WHEREAS the board wishes to amend the bylaw to increase the bulk water rates to reflect the COVID-19 response and renewal plan for the Comox Valley Water System;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1. Bylaw No. 190 being “Comox Valley Water Supply System Bulk Water Rates Bylaw No. 190, 2011” is hereby amended by:
 - (a) Replacing Schedule A “Comox Valley Water Supply System Bulk Water Rates” with the attached Schedule A.
