## **COMOX VALLEY REGIONAL DISTRICT**

### **BYLAW NO. 650**

**A bylaw to establish a garbage collection service in a portion of Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands)**

**WHEREAS** under section 332 of the *Local Government Act* (RSBC, 2015, C. 1) a regional district may operate any service the board considers necessary or desirable for all or part of the regional district;

**AND WHEREAS** the board of the Comox Valley Regional District wishes to establish a service to provide garbage collection to a portion of Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands);

**AND WHEREAS** the approval of the inspector of municipalities has been obtained under section 342 of the *Local Government Act* (RSBC, 2015, C. 1); and

**AND WHEREAS** the approval for the participating area was obtained by alternative approval process under section 345 of the *Local Government Act* (RSBC, 2015, C. 1);

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

#### **Service**

1. (a) The service established under this bylaw is the service of undertaking, operating and carrying out the collection, removal and disposal of waste and noxious, offensive or unwholesome substances in the service area, including the carrying out of any other act or operation for the reduction, recycling or disposal of waste and noxious, offensive or unwholesome substances.
- (b) The service shall be known as the Southern Garbage Collection Service (the ‘service’).

#### **Boundaries**

2. The boundaries of the service shall be that portion of Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands) as identified in Schedule A attached to and forming part of this bylaw.

#### **Participating areas**

3. Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands)) is the participating area in the service.

#### **Cost recovery**

4. As provided in section 378 of the *Local Government Act* (RSBC, 2015, C. 1), the annual cost for this service shall be recovered by one or more of the following:
  - (a) fees and charges imposed under section 363 of the *Local Government Act* (RSBC, 2015, C. 1);
  - (b) revenues received by way of agreement, enterprises, gift, grant or otherwise.

5. In accordance with section 339(1)(e) of the *Local Government Act (RSBC, 2015, C. 1)*, the maximum amount that may be requisitioned annually for the cost of the service is \$0.00 per \$1,000 applied to the net taxable value of land and improvements for regional hospital district purposes.

6. This Bylaw No. 650 may be cited for all purposes as “Comox Valley Regional District Southern Garbage Collection Service Establishment Bylaw No. 650, 2021”.
