BYLAW NO. 606

A bylaw to amend the King Coho Wastewater Service parcel tax for 2020 to raise funds for the capital improvements being made to the King Coho Wastewater Treatment Plant

WHEREAS the King Coho Wastewater Service is a service of the Comox Valley Regional District established by Bylaw No. 495 being “King Coho Wastewater Service Establishment Bylaw No. 495, 2017”;

AND WHEREAS a regional district board is empowered by the *Local Government Act* (RSBC, 2015, c.1) to impose and levy a parcel tax to provide all or part of the funding for a service;

AND WHEREAS the Board desires to update the parcel tax for the King Coho Wastewater Service to raise funds for the capital improvements being made to the King Coho Wastewater Treatment Plant;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1. Bylaw No. 563 being “King Coho Wastewater Service Parcel Tax Bylaw No. 563, 2018” is hereby amended as follows:
 - a) By deleting subsections 1(c) and replacing it with the following:

“(c) The parcel tax to be levied in 2020 is \$1,786.41 per strata lot.”
