Re: Island Corridor Foundation - Board of Directors

This correspondence follows-up on our previous discussions about the appointment to the Island Corridor Foundation (ICF) Board of Directors.

On January 26, 2016, the Comox Valley Regional District (CVRD) Board appointed you to the ICF. At that time the CVRD Board determined that your appointment was to conclude at the end of your term of office and this was communicated to ICF.

Following the end of your term, in October 2018, we spoke. It was my understanding you offered to cooperate with the will of the CVRD Board - you were willing to step down or continue. I informed the Board of this and on December 18, 2018, the CVRD Board appointed Director Daniel Arbour to the ICF. Director Arbour is now the ICF member representing the CVRD.

Despite the Island Corridor Foundation's bylaws, which account for ICF directors to continue for two-year terms (ending in April), the CVRD has made its decision that Director Arbour is to represent the CVRD at ICF member meetings and be the CVRD's director on the ICF. Director Arbour will have voting rights at member meetings and seek nomination to the ICF Board of Directors at the next annual general meeting. Director Arbour has offered to communicate to the CVRD Board on ICF matters and keep them informed. This is consistent with other ICF Board members who communicate with their regional districts.

Can you please confirm whether you will respect the decision of the CVRD Board, such that Director Arbour can proceed with seeking the director nomination, as per the CVRD Board of Directors intent? I propose to update the Board on this matter at their regular meeting of March 19, 2019. Your response in writing would be appreciated.

If you have any questions, please let me know right away. Your service to the Comox Valley and the ICF is very important and we want to ensure the transition between your role as an ICF Director and Director Arbour's role is seamless and supportive.

Your earliest attention to this matter is appreciated.
