A bylaw to amend the service establishing bylaw for the Rural Cumberland Fire Protection Service to extend the boundaries to include additional properties

WHEREAS the Rural Cumberland Fire Protection Service was created by the adoption of Bylaw No. 192 being "Rural Cumberland Fire Protection Service Establishment Bylaw No. 192, 2011" on the 13th day of December, 2011;

AND WHEREAS the board wishes to extend the boundaries to include the Cumberland Campground, the entirety of the Courtenay Fish and Game Club and seventeen (17) other adjacent properties;

AND WHEREAS participating area approval has been obtained in writing from the directors of Electoral Areas 'A' (Baynes Sound – Denman / Hornby Islands) and 'C' (Puntledge – Black Creek) in accordance with the *Local Government Act* [RSBC 2015] c. 1;

AND WHEREAS the approval of the Inspector of Municipalities has been obtained;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

- 1. The boundaries of the Rural Cumberland Fire Protection Service area as established by the Rural Cumberland Fire Protection Service Establishment Bylaw No. 192 are hereby extended to include the lands outlined in Schedule B, which is attached hereto and forms part of this bylaw.
- 2. Schedule A of the Rural Cumberland Fire Protection Service Establishment Bylaw No. 192 is hereby deleted and replaced by the amended Schedule A attached hereto and forming part of this bylaw.

Effective Date

3. This bylaw will come into effect on December 31, 2018.


