# COMOX VALLEY REGIONAL DISTRICT BYLAW NO. 490

## A bylaw to establish a capital reserve fund for the Merville Fire Protection service

**WHEREAS** the board of the Comox Valley Regional District operates a service for the Merville Fire Protection under "Merville Fire Protection Service Establishment Bylaw No. 484, 2017";

**AND WHEREAS** pursuant to section 188 of the *Community Charter* [SBC, 2003, c. 26] applicable to regional districts by section 377(2) of the *Local Government Act* [RSBC, 2015, c. 1], a regional district may, by bylaw, establish a reserve fund for a specified purpose and direct that money to be placed to the credit of that reserve fund;

**AND WHEREAS** the board of the Comox Valley Regional District wishes to establish a reserve fund to provide for capital expenditures;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

#### Reserve fund establishment

1. There is hereby established a reserve fund to be known as the Merville Fire Protection service capital reserve fund.

### Reserve fund purpose

2. The purpose of the reserve fund is to provide a reserve to contribute towards the capital costs associated with the Merville Fire Protection service, including, but not limited to, land acquisition and development, machinery and equipment as necessary, and the extension or renewal of existing capital works.

This Bylaw No. 490 may be cited as the "Merville Fire Protection Service Capital Reserve Fund Establishment Bylaw No. 490, 2017."
