## **BYLAW NO. 494**

### A bylaw to amend the municipal ticket information bylaw to increase fines associated with the fireworks regulations service from \$100 to \$500

**WHEREAS** section 414 of the *Local Government Act* (RSBC, 2015, c. 1), and sections 264 and 265 of the *Community Charter* authorize the Comox Valley Regional District to enact a bylaw to allow the use of ticketing for enforcement offences;

**WHEREAS** the Comox Valley Regional District adopted Bylaw No. 104 being the "Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010" on April 27, 2010;

**WHEREAS** the Comox Valley Regional District desires to increase fine amounts associated with the fireworks regulations service from \$100 to \$500;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:
