A bylaw to amend the development cost charges for the Comox Valley sewerage system

WHEREAS Bylaw No. 2445 being the "Comox Valley Sewerage System Development Cost Charges Bylaw No. 2445, 2002" was adopted on the 29th day of July 2002";

AND WHEREAS Section 397 of the Local Government Act (RSBC, 2015, c. 1) authorizes the Comox Valley Regional District to impose fees for regional district's services;

AND WHEREAS the board desires to update the bylaw to amend the development cost charges for the Comox Valley sewerage system;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:
