**BYLAW NO. 501**

**A bylaw to amend the service establishing bylaw for the Merville Fire Protection Service to include certain properties into the service area that had been omitted through previous boundary amendments and through the conversion process**

**WHEREAS** the Merville Fire Protection Service was created by the adoption of Bylaw No. 484 being “Merville Fire Protection Service Establishment Bylaw No. 484, 2017” on the 29<sup>th</sup> day of August 2017;

**AND WHEREAS** the board wishes to include certain properties into the service area that had been omitted through previous boundary amendments and through the conversion process;

**AND WHEREAS** participating area approval has been obtained by writing from the directors of Electoral Areas ‘B’ (Lazo North) and ‘C’ (Puntledge – Black Creek) under section 347 of the *Local Government Act* [RSBC 2015] c. 1;

**AND WHEREAS** the approval of the inspector of municipalities has been obtained under section 342 of the *Local Government Act* [RSBC 2015] c. 1;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

**Amendment**

1. (1) Bylaw No. 484 being “Merville Fire Protection Service Establishment Bylaw No. 484, 2017” is hereby amended by adding to the service area boundary the following properties as shown on the attached schedule B, which were omitted through previous boundary amendments and through the conversion process in 2017:

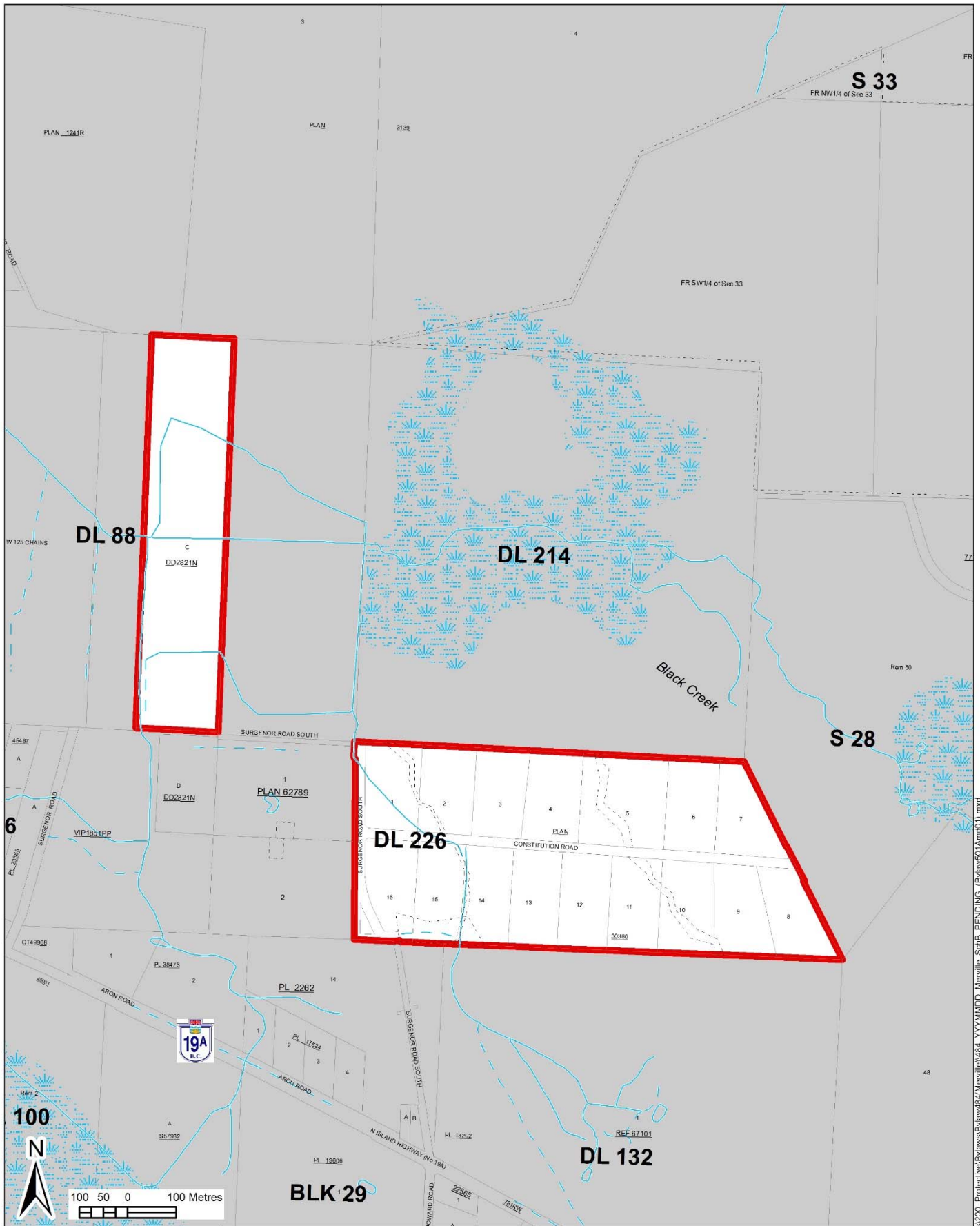
