COMOX VALLEY REGIONAL DISTRICT BYLAW NO. 534

A bylaw to amend the municipal ticket information bylaw to provide specific fines with respect to fire regulations and water conservation.

WHEREAS section 414 of the *Local Government Act* (RSBC, 2015, c. 1), and sections 264 and 265 of the *Community Charter* authorize the Comox Valley Regional District to enact a bylaw to allow the use of ticketing for enforcement offences;

WHEREAS the Comox Valley Regional District adopted Bylaw No. 104 being the "Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010" on April 27, 2010;

AND WHEREAS the board desires to update the bylaw to reference and the Black Creek – Oyster Bay Water Conservation bylaw, Rural Cumberland Fire Service Regulations bylaw and to provide specific fines for the current fire service regulations regarding high-risk activities within the local fire service areas;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:
