Chair Jolliffe called the public hearing to order at 6:00 pm and read a prepared statement regarding the public hearing procedures. Approximately 10 members of the public were present for this public hearing.

# Bylaw No. 537, being the "Comox Valley Zoning Bylaw 2005, Amendment No. 74" (CVRD)

R. Holme, Long-Range Planner, presented an overview of the application for Bylaw No. 537 being "Comox Valley Zoning Bylaw, 2005, Amendment No. 74" to prohibit the production and retail sale of non-medical cannabis in the electoral areas. Any proposed non-medical cannabis use would require a rezoning or a temporary use permit.

R. Holme summarized the written submissions from the following respondents:

R. Holme also presented the following meeting minutes from the CVRD's advisory planning commissions which considered Bylaw No. 537:

- Electoral Area A (Baynes Sound Denman/Hornby Islands) Advisory Planning Commission June 25, 2018
- Electoral Area B (Lazo North) Advisory Planning Commission June 27, 2018
- Electoral Area C (Puntledge-Black Creek) Advisory Planning Commission June 27, 2018

Those submissions and those received during the public hearing are attached as Appendix A to these minutes.

Chair Jolliffe called for speakers regarding the proposed bylaw and advised that any written submissions regarding the proposed bylaws must be brought forward before the close of the public hearing. **Hugh Van Hech, Black Creek**, lives nearby a medical cannabis grow operation and stated that there are times when he is unable to go outside, and there are often police at the facility. Mr. Van Hech expressed concern regarding proposed amendment no. 6 of the bylaw which references issuing temporary use permits or rezonings and questioned as to how this would be enforced. Mr. Van Hech believes that the benefits of permitting recreational cannabis production and sales will be short-lived. Those who live in rural areas near Agricultural Land Reserve land will be most affected.

Tom Spratt, Courtenay, spoke in support of Bylaw No. 537 and encouraged the directors to consider some negative aspects of cannabis use such as addiction, psychological and physical dependence, health impacts and impact on youth (Mr. Spratt's presentation is attached in Schedule A).

Randy Bennett, Courtenay, spoke regarding the benefits of cannabis use for seniors and those with addiction issues. Mr. Bennett encouraged the directors to wait and see what the government regulations look like before moving forward with an amendment to the zoning bylaw.

Chair Jolliffe called a second time for speakers to the public hearing and reminded the public that any written submissions regarding the proposed bylaws must be brought forward before the close of the public hearing.

Chair Jolliffe called for a final time for speakers and asked that all written submissions be brought forward. Hearing no speakers, the chair declared the public hearing terminated for Bylaw No. 537, being the "Comox Valley Zoning Bylaw, 2005, Amendment No. 74" (CVRD).

Dear CVRD board members,

I would like to speak in favor of the adoption of Bylaw 537, Comox Valley Zoning Bylaw 2005, Amendment No.74

Although I realize that the laws of Canada are being changed to make marijuana legal, there are some points I would like to have the board consider.

- Marijuana is an addictive substance and can negatively affect a person's health. Some of the known physical withdrawal symptoms include chills, sweats, cravings, insomnia, loss of appetite, nausea, anxiety and irritability.
- 2. Psychological dependence to marijuana is rising because of the increasing potency of genetically engineered plants: THC levels are at 20% and higher compared to 2-4% levels in earlier years. Also, there are negative effects from the production and use of concentrated products with THC levels of 40-80%. In addition, some users are using multiple times a day, leading to addiction.
- 3. We know the negative affects on human lungs of cigarette smoking. Should another form of smoking be facilitated?
- 4. In California, addiction treatment practitioners are seeing a surge in demand for help, particularly among adolescents. A common complaint by parents of adolescent users is that performance in school declines, along with involvment in sports and other extra-curricular activities.

In light of these points, it is my belief that we should do what we can to discourage marijuana use, and that bylaw 573, amendment 74 should be adopted.

If the bylaw should not be adopted, then I would recommend that outlets would be few in number, and low in profile.
