BYLAW NO. 399

A bylaw to amend the service establishing bylaw for the Black Creek community centre contribution service to increase the maximum requisition by 25 percent

WHEREAS the Black Creek community centre contribution service was created by the adoption of Bylaw No. 47 being “Black Creek Community Centre Contribution Service Establishment Bylaw No. 47, 2009” on the 30th day of July 2009;

AND WHEREAS the board wishes to increase the maximum requisition amount by 25 per cent (to \$72,500), as per the Local Government Act Regional District Establishing Bylaw Approval Exemption Regulation, effective January 1, 2016;

AND WHEREAS participating area approval has been obtained in writing from the director of Electoral Area ‘C’ (Puntledge – Black Creek) under section 801.5 of the *Local Government Act*;

AND WHEREAS this amendment is exempt from inspector of municipalities’ approval under regulation where the owner consents to the boundary amendment by petition;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1. Bylaw No. 47 being “Black Creek Community Centre Contribution Service Establishment Bylaw No. 47, 2009” is hereby amended by replacing section 5 (maximum requisition), which reads:

“The maximum amount that may be requisitioned under section 4 annually for the cost of the service is the greater of \$58,000 or \$0.11 per \$1,000 of net taxable value of land and improvements in the service area.”

with the following section 5 (maximum requisition):

“The maximum amount that may be requisitioned under section 4 annually for the cost of the service is the greater of \$72,500 or \$0.14 per \$1,000 of net taxable value of land and improvements in the service area.”

Effective date

2. This Bylaw No. 399 being “Black Creek Community Centre Contribution Service Establishment Bylaw No. 47, 2009, Amendment No. 1” shall come into effect on January 1, 2016.

Citation

This Bylaw No. 399 may be cited as “Black Creek Community Centre Contribution Service Establishment Bylaw No. 47, 2009, Amendment No. 1”.
