A bylaw to amend the Comox Valley water conservation bylaw to incorporate the Sandwick water service into this bylaw, following the Sandwick Waterworks District conversion and subsequent connection to the Comox Valley water supply system

WHEREAS the Comox Valley Regional District adopted Bylaw No. 129 being the "Comox Valley Water Conservation Bylaw 2010" on May 25, 2010;

AND WHEREAS the board desires to update the bylaw to incorporate the Sandwick water service into this bylaw, following the Sandwick Waterworks District conversion and subsequent connection to the Comox Valley water supply system;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

- 1. Bylaw No. 129 being "Comox Valley Water Conservation Bylaw 2010" is hereby amended by:
 - (a) Replacing the definition of "Electoral area service areas" in section 1 (Definitions), which reads as follows:

"Electoral area service areas means those portions of Electoral Areas A, B, and C that are within the service areas created by:

- Bylaw No. 1453 being "Marsden/Camco Water Local Service Area Conversion and Establishment Bylaw, 1992";
- Bylaw No. 1494 being "Greaves Crescent Water Local Service Area Establishment By-law, 1993"
- Bylaw No. 1678 being "Arden Water Local Service Area Conversion and Establishment Bylaw, 1994";
- Bylaw No. 1886 being "Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996"; and
- Bylaw No. 1999 being "England Road Water Local Service Area Establishment Bylaw No. 1999, 1998";"

with the following:

"Electoral area service areas means those portions of Electoral Areas A, B, and C that are within the service areas created by:

- Bylaw No. 1453 being "Marsden/Camco Water Local Service Area Conversion and Establishment Bylaw, 1992";
- Bylaw No. 1494 being "Greaves Crescent Water Local Service Area Establishment By-law, 1993"
- Bylaw No. 1678 being "Arden Water Local Service Area Conversion and Establishment Bylaw, 1994";

- Bylaw No. 1886 being "Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996"; and
- Bylaw No. 1999 being "England Road Water Local Service Area Establishment Bylaw No. 1999, 1998";
- Conversion under Order in Council 921 (approved and ordered December 7, 2016) of the Sandwick WaterWorks District to the Comox Valley Regional District Sandwick water service;"
