BYLAW NO. 575

A bylaw to repeal the Pesticide Awareness Service

WHEREAS the Pesticide Awareness Service was created by the adoption of Bylaw No. 2601 being “Regional District Pesticide Awareness Service Establishment Bylaw No. 2601, 2003” on February 23, 2004;

AND WHEREAS the board wishes to repeal this service;

AND WHEREAS the approval of the inspector of municipalities was obtained under section 349 of the Local Government Act (RSBC, 2015, C. 1);

AND WHEREAS participating area approval has been obtained in writing from the council of the Village of Cumberland and the directors of Electoral Areas ‘A’ (Baynes Sound – Denman / Hornby Islands), ‘B’ (Lazo North) and ‘C’ (Puntledge – Black Creek) under section 349 of the *Local Government Act* (RSBC, 2015, c.1);

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Repeal

1. Bylaw No. 2601 being “Regional District Pesticide Awareness Service Establishment Bylaw No. 2601, 2003” and all amendments thereto are hereby repealed.

Effective date

2. This Bylaw No. 575 being “Regional District Pesticide Awareness Service Repeal Bylaw No. 575, 2019” takes effect on April 30, 2020.
