A bylaw to amend the boundaries of the Royston Garbage Collection Service

WHEREAS the Royston Garbage Collection Service was created by the adoption of Bylaw No. 118 being “Royston Garbage Collection Service Establishment Bylaw No. 118, 2010” on the 31st day of August 2010;

AND WHEREAS the Board of the Comox Valley Regional District has been petitioned by the property owners to extend the boundaries of the service area to include the lands outlined on Schedule ‘A’ of this bylaw;

AND WHEREAS this amendment is exempt from inspector of municipalities’ approval under regulation where the sufficient and valid petition to the boundary amendment is received;

AND WHEREAS the Corporate Legislative Officer has certified the petitions as sufficient and valid in accordance with the requirements of the *Local Government Act* and the *Community Charter*;

AND WHEREAS the director for Electoral Area ‘A’ (Baynes Sound-Denman/Hornby Islands) has consented to the adoption of this bylaw in writing;

NOW THEREFORE the Board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

1. Bylaw No. 118 being “Royston Garbage Collection Service Establishment Bylaw No. 118, 2010” is hereby amended as follows:
 - (1) By amending the boundaries of the Royston Garbage Collection Service area to include the properties outlined in red on Schedule ‘A’ attached to and forming part of this bylaw.
 - (2) The boundaries of the Royston Garbage Collection Service shall be those portions of Electoral Area ‘A’ of the Comox Valley Regional District as shown in red on the attached Schedule ‘B’ which forms part of this bylaw.
