# **BYLAW NO. 496**

### A bylaw to amend the development cost charges for the Comox Valley water system

**WHEREAS** the board of the regional district adopted Bylaw No. 2342 being "Regional District of Comox-Strathcona Water Supply Development Cost Charges Bylaw 2001" on the 26<sup>th</sup> day of February 2001;

**AND WHEREAS** Section 397 of the Local Government Act (RSBC, 2015, c. 1) authorizes the Comox Valley Regional District to impose fees for regional district's services;

**AND WHEREAS** the board of the regional district wishes to amend the development cost charges for the Comox Valley water system to assist in funding the required supply and storage improvements of the Comox Valley water system;

**THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

#### Amendment

- 1. Bylaw No. 2342 being "Regional District of Comox-Strathcona Water Supply Development Cost Charges Bylaw 2001" is hereby amended by:
  - (a) Replacing the table in schedule 'A' as follows:
