**A Bylaw to Amend the “Comox Valley Zoning Bylaw, 2005”
being Bylaw No. 2781**

The board of the Comox Valley Regional District, in open meeting assembled, enacts the following amendments to the “Comox Valley Zoning Bylaw, 2005,” being Bylaw No. 2781:

Section One Text Amendment

- 1) Bylaw No. 2781, being the “Comox Valley Zoning Bylaw, 2005,” is hereby amended as set out in Schedule A attached to and forming part of this bylaw.

- 1) This Bylaw No. 543 may be cited as the “Comox Valley Zoning Bylaw, 2005, Amendment No. 76.”

Section One Text Amendment

1. Bylaw No. 2781, being the “Comox Valley Zoning Bylaw, 2005”, is hereby amended by:
 - a. Rezoning the property legally described as Lot C, Block 29, Comox District, Plan 25306 (2410 Sackville Road) from Rural Eight (RU-8) to Rural Eight – exception 8 (RU-8-8); and
 - b. Inserting the following zoning exception in Part 1200 “Exceptions to Zone Designations”

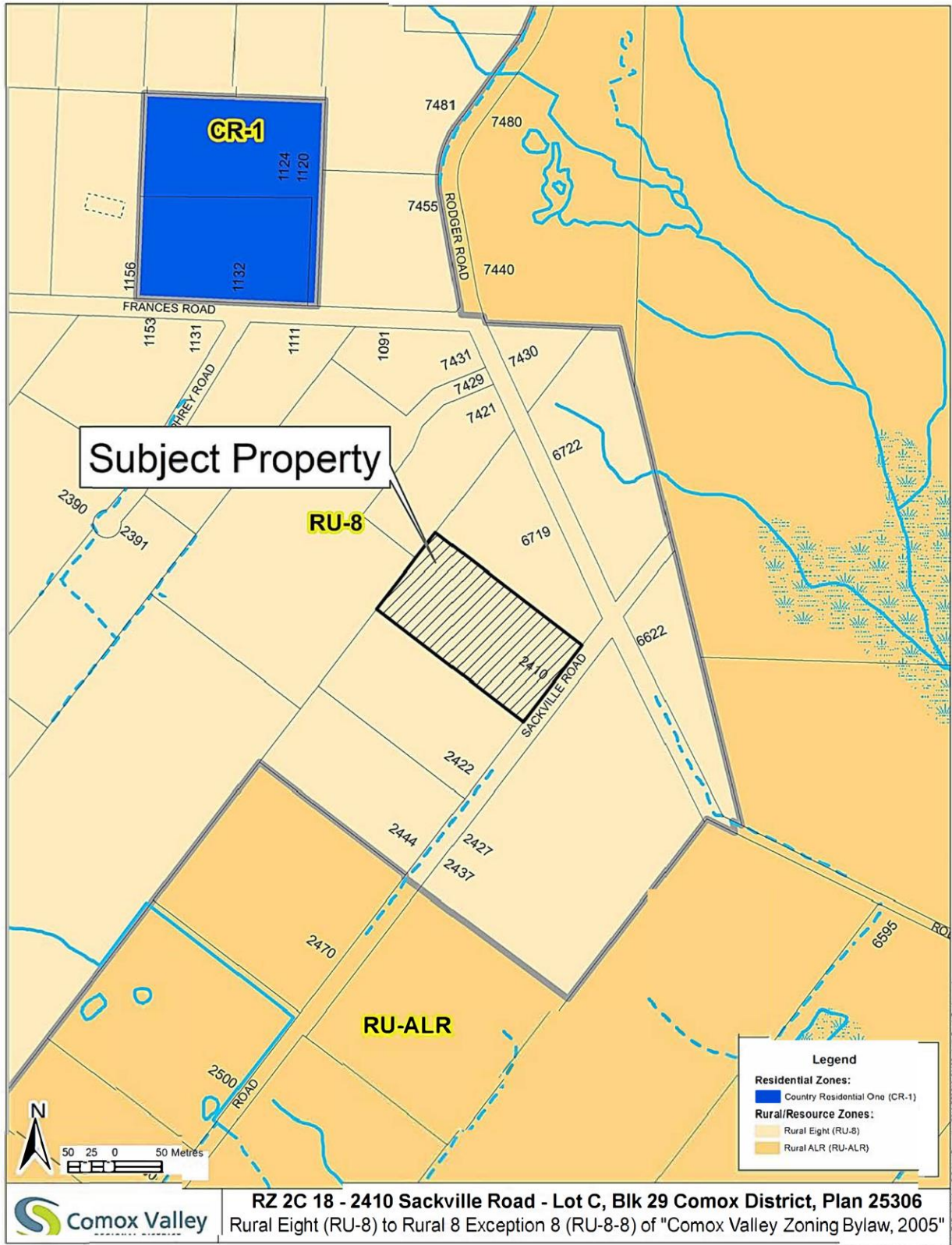

Section Two Map Amendment

- 1) Map A-11 of Bylaw No. 2781, being the “Comox Valley Zoning Bylaw, 2005”, is hereby amended by rezoning property legally described as “Lot C, Block 29, Comox District, Plan 25306” (2410 Sackville Road) from Rural Eight (RU-8) to Rural Eight – exception 8 (RU-8-8) as shown on Appendix 1.
