A bylaw to extend the Black Creek/Oyster Bay fire protection local service area to include property located along the south-eastern boundary of the service area

WHEREAS Bylaw No. 1964, being the "Black Creek/Oyster Bay Fire Protection Local Service Area Conversion/Establishment Bylaw No. 1964, 1997" adopted on the 27th day of April 1998 converted the Black Creek/Oyster Bay fire protection specified area to a service known as the "Black Creek/Oyster Bay fire protection local service area" for the purpose of providing fire prevention, suppression and assistance;

AND WHEREAS the board of the Comox Valley Regional District wishes to amend the "Black Creek/Oyster Bay Fire Protection Local Service Area Conversion/Establishment Bylaw No. 1964, 1997" to extend its boundaries to include property located along the south-eastern boundary of the service area and noted in the staff report dated May 1, 2015 (PID is 004-814-398. LT3 PLAN 1241R BLOCK 29 LNDDST15) thus coinciding with a reduction in the Merville fire protection improvement district and also to conduct an administrative update to include all properties in the service in their entirety;

AND WHEREAS the Comox Valley Regional District director for Puntledge – Black Creek (Area 'C') and the Strathcona Regional District director for Oyster Bay – Buttle Lake (Area 'D') have consented to the adoption of this bylaw;

AND WHEREAS this amendment is exempt from inspector of municipalities' approval under regulation where the owner consents to the boundary amendment by petition;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

- 1. Bylaw No. 1964 being "Black Creek/Oyster Bay Fire Protection Local Service Area Conversion Bylaw 1997" is hereby amended by:
 - (a) amending the boundaries of the service area to include the area outlined on the attached schedule 'B';
 - (b) deleting schedule 'A' of Bylaw No. 1964 and substituting the attached schedule 'A' therefore.

2. This bylaw comes into effect at the same time as supplementary letters patent are issued by the Province of British Columbia that amend the boundaries of the Merville Fire Protection Improvement District to remove the property outlined on the attached schedule 'B'.

This Bylaw No. 382 may be cited for all purposes as the "Black Creek/Oyster Bay Fire Protection Local Service Area Conversion/Establishment Bylaw No. 1964, 1997, Amendment No. 5".


