A bylaw to amend the boundaries of the Marsden/Camco Road water local service area

WHEREAS the board adopted Bylaw No. 1453 being "Marsden Camco Local Service Area Conversion and Establishment Bylaw 1992" which converted the Marsden/Camco Road water service specified area, to a local service area, to include portions of Electoral Area "C";

AND WHEREAS the board wishes to adjust the boundaries of the service area to add properties that are located on Lake Trail Road, which is further supported by a Comox Valley water committee resolution dated May 12, 2015 that permits the two subject properties to receive water from the Comox Valley water system;

AND WHEREAS this amendment is exempt from inspector of municipalities' approval under regulation where the owners consent to the boundary amendment by petition;

AND WHEREAS the director for Electoral Area 'C' (Puntledge – Black Creek) has consented to the adoption of this bylaw in writing;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

- 1. Bylaw No. 1453 being "Marsden/Camco Water Local Service Area Conversion and Establishment Bylaw, 1992" is hereby amended by:
 - (a) the addition of properties described as Lot 10, Plan 22672, District Lot 94, Comox Land District; and Lot 9, Plan 22672, District Lot 94, Comox Land District as shown on the attached Schedule 'B', which forms part of this bylaw; and
 - (b) Repealing schedule 'A' and replacing it with the attached schedule 'A'.
