A bylaw to amend Comox Valley Water Supply System Bulk Water Rates Bylaw No. 190, 2011 to amend the bulk water rate for 'other than local government' users effective April 1, 2020.

WHEREAS Bylaw No. 190 being "Comox Valley Water Supply System Bulk Water Rates Bylaw No. 190, 2011" is a bylaw of the Comox Valley Regional District and was adopted on October 25, 2011;

AND WHEREAS the board wishes to amend the bylaw to increase the bulk water rate for 'other than local government' users effective April 1, 2020 to reflect capital, operating and administration costs associated with operation of the bulk water standpipe;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:
