A bylaw to amend the Union Bay Water Service Water Tolls Bylaw

WHEREAS the Union Bay Improvement District adopted "Bylaw No. 278 Water Tolls and Other Charges, 2020" on October 17, 2019;

AND WHEREAS Order in Council No. 221 was issued by the Lieutenant Governor in Council on April 6, 2021 ordering the transfer of obligations from the Union Bay Improvement District to the Comox Valley Regional District and the Union Bay Improvement District water service was established as a Comox Valley Regional District service by the conversion effective July 1, 2021;

AND WHEREAS the Comox Valley Regional District Board wishes to amend Bylaw No. 278 to correct the monthly allowable consumption per tier;

NOW THEREFORE the Board of the Comox Valley Regional District in open meeting assembled enacts as follows:
