No regulation change.

**BYLAW NO. 674**

**A bylaw to amend the headings in Schedule A of the Royston Water Conservation Bylaw to be consistent with the watering schedule.**

**WHEREAS** the Comox Valley Regional District adopted Bylaw No. 535 being the “Royston Water Conservation Bylaw No. 535, 2018” on June 5, 2018;

**AND WHEREAS** the board desires to update the bylaw to amend the headings in Schedule A of the bylaw to be consistent with the watering schedule;

**NOW THEREFORE** the Board of the Comox Valley Regional District in open meeting assembled enacts as follows:

**Amendment**

1. Bylaw 535 being “Royston Water Conservation Bylaw No. 535, 2018” is hereby amended by:
  - (a) Replacing the heading for Stage 1 in Schedule A which reads:  
“STAGE 1-TWO DAYS PER WEEK LAWN WATERING”  
with the following:  
“STAGE 1 - WATER USE RESTRICTIONS”
  - (b) Replacing the heading for Stage 2 in Schedule A which reads:  
“STAGE 2 - ONE DAY PER WEEK LAWN WATERING”  
with the following:  
“STAGE 2 - WATER USE RESTRICTIONS”
  - (c) Replacing the heading for Stage 3 in Schedule A which reads:  
“STAGE 3 - NO LAWN WATERING”  
with the following:  
“STAGE 3 - WATER USE RESTRICTIONS”

(d) Replacing the heading for Stage 4 in Schedule A which reads:

“STAGE 4 - EXTREME CONDITIONS”

with the following:

“STAGE 4 - WATER USE RESTRICTIONS”
