A bylaw to amend the service establishing (conversion) bylaw for the Denman Island Water Local Service Area to amend the boundaries.

WHEREAS the Denman Island water local service area was converted to a regional district service by the adoption of Bylaw No. 1567 being "Denman Island Water Local Service Area Conversion and Establishment Bylaw, 1993" on the 16th day of December 1993;

AND WHEREAS the board wishes to adjust the boundaries of the service area to reflect the exclusion of the following property:

Lot 2 Plan VIP28719 Section 8 Land District 32 DENMAN ISLAND.

AND WHEREAS this amendment is exempt from inspector of municipalities' approval under regulation where the owner consents to the boundary amendment by petition;

AND WHEREAS the director for Electoral Area 'A' (Baynes Sound-Denman/Hornby Islands) has consented to the adoption of this bylaw in writing;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Amendment

- 1. (1) Bylaw No. 1567 being "Denman Island Water Local Service Area Conversion and Establishment Bylaw, 1993" is hereby amended to exclude:
 - Lot 2 Plan VIP28719 Section 8 Land District 32 DENMAN ISLAND.

in the Denman Island Water Local Service Area, as shown on the attached schedule 'B';

(2) The boundaries of the Denman Island Water Local Service Area shall be those portions of Electoral Area 'A' of the Comox Valley Regional District as shown on the attached schedule 'A' which forms part of this bylaw.


