BYLAW NO. 506

A bylaw to establish a service within Electoral Area 'B' to provide for the Sandwich water service

WHEREAS under section 338 of the *Local Government Act* (RSBC, 2015, c.1) the Comox Valley Regional District is authorized to adopt a service establishment bylaw prior to operating a service;

AND WHEREAS order in council no. 921 was issued by the Lieutenant Governor in Council on December 7, 2016 ordering the transfer of obligations from the Sandwich Waterworks District to the Comox Valley Regional District and the Sandwich Waterworks District water service was established as a Comox Valley Regional District service by the conversion effective December 31, 2016;

AND WHEREAS the approval of the inspector of municipalities has been obtained under section 342 of the *Local Government Act* (RSBC, 2015, c.1);

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Service Established

1. The Comox Valley Regional District hereby establishes within Electoral Area 'B' (Lazo North) a service for the distribution of water for the area to be known as the Sandwich water service.

Boundaries of the Service Area

2. The boundaries of the Sandwich water service are shown on the map attached to this bylaw as schedule 'A'.

Participating Area

3. The only participating area for the Sandwich water service is Electoral Area 'B' (Lazo North).

Cost Recovery

4. As provided in section 378 of the *Local Government Act* (RSBC, 2015, C. 1), the annual cost for this service shall be recovered by one or more of the following:
 - a) property value taxes;
 - b) parcel taxes;
 - c) fees and charges imposed under section 363 of the *Local Government Act* (RSBC, 2015, C. 1);
 - d) revenues raised by other means authorized by the *Local Government Act* (RSBC, 2015, C. 1) or another Act; and
 - e) revenues received by way of agreement, enterprises, gift, grant or otherwise.
