A bylaw to amend the municipal ticket information bylaw to update the section references for the Comox Valley Water Conservation Bylaw within the fines schedule.

WHEREAS the *Local Government Act* (RSBC, 2015, c. 1) and the *Community Charter* authorize the Comox Valley Regional District to enact a bylaw to allow the use of ticketing for enforcement offences;

WHEREAS the Comox Valley Regional District adopted Bylaw No. 104 being the "Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010" on April 27, 2010;
