## **BYLAW NO. 578**

A bylaw to amend the municipal ticket information bylaw to reference the current fire regulations bylaw of the Rural Cumberland Fire Protection Service

**WHEREAS** the Comox Valley Regional District adopted Bylaw No. 104 being the "Comox Valley Regional District Municipal Ticket Information Bylaw No. 104, 2010" on April 27, 2010;

**AND WHEREAS** the board desires to update the bylaw to reference the current fire services regulations bylaw of the Rural Cumberland Fire Service;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:
