## **BYLAW NO. 613**

## A bylaw to amend the payment requirements for capital improvement charges

**WHEREAS** the board of the Comox Valley Regional District adopted Black Creek/Oyster Bay Water Local Service Area Capital Improvement Charge Bylaw No. 2462, 2002 on the 26<sup>TH</sup> day of August 2002;

**AND WHEREAS** the board of the Comox Valley Regional District wishes to amend the payment requirements for capital improvement charges for those properties serviced by the private water utility known as the Watutco Water System;

**NOW THEREFORE** the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

### Amendment

- 1. Bylaw No. 2462 being "Black Creek/Oyster Bay Water Local Service Area Capital Improvement Charge Bylaw No. 2462, 2002" is hereby amended by:
  - a) Inserting a new section 3 as follows:
    - "3. As an exception to Section 2, the regional district may amortize the applicable charge set out in Schedule 'A" to this bylaw over a ten (10) year period for those properties shown outlined in red on Schedule 'B'."
    - and renumbering the subsequent section as required.
  - b) Adding "Schedule 'B' Bylaw No. 2462 being "Black Creek/Oyster Bay Water Local Service Area Capital Improvement Charge Bylaw No. 2462, 2002" attached hereto and forming part of this bylaw.
