Purpose

To provide the Committee of the Whole with the proposed 2019 - 2023 Financial Plan and work plan highlights for the Comox Valley Emergency Management Service, function 270.

Recommendation from the Chief Administrative Officer:

THAT the proposed 2019 - 2023 financial plan for the Comox Valley Emergency Management Service, function 270, be approved.

Executive Summary

The following highlights some of the key elements that will influence the financial plan and work plan.

- 2019 proposed requisition is \$89,965 based on a tax levy of \$0.0121 per \$1,000 and represents an increase of \$21,610 over 2018;
- maximum tax requisition is \$201,082 based on tax levy of \$0.03 per \$1,000;
- property assessed at \$400,000, the tax levy would be \$4.84;
- the Town of Comox, City of Courtenay and Village of Cumberland participate through service agreements (total contributions for 2019 are \$137,003);
- personnel costs are effected by allocation of a Branch Assistant to reflect actual time provided, salary compensation adjustment and mandatory employment related costs;
- work plan highlights in 2019 include supporting the design and delivery of an earthquake functional exercise in 2020, enhancing the CVRD's Connect Rocket public mass notification system to support more hazards and risks, evacuation route planning to develop guidelines and tools subject to funding through the Union of BC Municipalities and procurement of a dedicated emergency / disaster regional radio frequency.

Reserves

A contribution from the future expenditures reserve to operations in the amount of \$23,196 is proposed in order to offset the need for further requisition increases in 2019.

Policy Analysis

In October, 28, 1991, Bylaw No. 1341 being "Electoral Areas 'A', 'B', and 'C' Emergency Program Extended Service Establishment Bylaw, 1991" was adopted by the Comox-Strathcona Regional District to establish an extended service for Electoral Areas A, B, and C to provide for preparation for emergencies. In January, 29, 1996 Bylaw No. 1816 being "Comox Valley Emergency Disaster Program Policy Agreement Bylaw No. 1816, 1996" authorized the CVRD to enter into an agreement for Emergency Program services with the City of Courtenay, Town of Comox and the Village of Cumberland to jointly exercise powers conferred pursuant to the *Emergency Program Act*, R.S.B.C. 1993, Chapter 41. The municipal agreements were renewed in 2017.

This service meets the Board's current interests in emergency planning as required under the *Provincial Emergency Program Act* for the Comox Valley which also fit part of the <u>CVRD 2015-2018</u> <u>Strategic Priorities.</u>

Financial Plan Overview

Each year the CVRD prepares an updated five year financial plan that represents the operation of each service from one budget year to the next. This proposed 2019 – 2023 financial plan was reviewed and supported by the Town of Comox, Village of Cumberland and City of Courtenay Chief Administrative Officers.

Table 1 summarizes the 2019 proposed budget as compared to the 2018 adopted budget. Significant variances from 2018 adopted budget will be discussed in the financial plan highlights section below.

Highlights of the 2019 - 2023 proposed financial plan for the Comox Valley Emergency Management Service, function 270, include:

Revenue Sources

There are two main local government revenue sources for the service, along with some grants and returning costs from a cost–sharing agreement listed below:

a. Tax requisition from the Electoral Areas A, B and C are shown in Table 2. The requisition is proposed at \$89,965 for 2019; an increase of \$21,610 in the requisition from 2018. The maximum levy is \$0.03 per \$1,000 of assessed value, resulting in a 2019 maximum requisition of \$201,082.

b. There are five-year administration service agreements with the Village of Cumberland, City of Courtenay and Town of Comox which expire at the end of 2021. Converted hospital values are used to determine the amount that will be collected from the member municipalities under the service agreements; shown in Table 3. The amount proposed for 2019 is \$137,003; an increase from 2018 of \$32,908.

c. Other Revenue:

Other revenue in Table 1 reflecting \$7,258 is recovered costs from Comox Valley Ground Search and Rescue as part of the shared cost agreement with the Emergency Program for operating and maintaining the Moray Avenue program location.

For the proposed 2019-2023 financial plan, no surplus carry forward is currently budgeted from 2018. Once the 2018 year end has been finalized, this will be reviewed and the requisition and municipal contributions may be adjusted.

Personnel

Personnel costs for 2019 are proposed to increase by \$24,407 over 2018 related to required wage/salary reclassification increases as well as increased benefits, WorkSafeBC and the new provincial Employee Health Tax.

Personnel apportionments to this service consist of 20 per cent of the Comox Valley Deputy Emergency Program Coordinator and 90 per cent of the Emergency Program Coordinator positions.

Operations

Operating expenses are proposed to increase by \$80,133 in 2019 to support the following:

• costs totalling \$35,000 for the design and delivery of an earthquake functional exercise in 2020 through a contractor to lead and support the local design team over the next two years; updating Rapid Damage Assessment, evacuation field kits and focused training delivery and developing Critical Infrastructure Assessment processes;

- \$4,000 for the development and delivery of training focused directly in supporting staff, first responders and volunteers in preparing for the earthquake exercise;
- training to support staff, first responders and volunteers with preparing to participate in the earthquake exercise;
- \$7,200 to enhance CVRD's Connect Rocket public mass notification system used now for boil water, Emergency Operations Centre team and residents/business in high flood risk area to support more hazards and risks. Cost recovery to 270 will occur through five CVRD departments whose emergency response guidelines identified a need for a mass notification system each contributing \$940;
- \$5,000 to establish an annual maintenance and testing program for regional radios, generators and equipment;
- \$25,000 grant through Union of BC Municipalities Community Emergency Preparedness Funding grant 'Evacuation Route Planning' to develop evacuation guidelines and tools to support a mass evacuation from qathet Regional District to CVRD and Strathcona Regional District as host communities; and
- \$5,000 to continue emergency radio infrastructure enhancement and procurement of a dedicated emergency/disaster radio frequency for the Comox Valley to improve regional emergency communications coordination as well as to support public works departments in the Comox Valley to communicate during mutual aid calls.

Reserves

The estimated balance in the reserve fund at the end of 2018 was \$58,743. In 2019, \$23,196 is proposed to be transferred to operations to offset any further 2019 requisition increase. Further transfers from the reserve are proposed throughout the 2019-2023 plan bringing the reserve balance to \$19,576 by 2023.

Citizen/Public Relations

The CVRD encompasses a geographic area of approximately 1,725 sq. kms and a population of 66,195 as per the 2016 census. Each year the region is experiencing greater impacts from climate change that could jeopardise the community. Such as we experienced this past summer when a severe lightning storm triggered over 60 wildfires on the North Island, as well increasing events such as damaging winds, heavy snow and severe rainfall, ice storms, high tides, higher storm surge events and of course we also face the highest nature threat on the westcoast of BC, a major earthquake.

The Comox Valley Emergency Program continues its efforts to build on the program's strong foundation to enhance its capacity and capabilities to operationally support, first responders, residents and businesses during a disaster as well as assisting them to become better prepared before an event.

The estimated residential tax rate in 2019 is \$0.0121 per \$1,000 of assessed value. For a home assessed at \$400,000, this equates to an annual tax levy of \$4.84 for 2019, a difference of \$0.64 from 2018.

Comox Valley Emergency Program Function 270 – 2018 Projects Year End Review

Response:

2018 BC and North Island Wildfires

- support by Emergency Support Services (ESS)
 - several families impacted by BC fires were provided ESS services in the Comox Valley and are still being supported;
 - o four people from Zeballos affected by North Island wildfires supported;
 - four people from Zeballos continue to be supported as there is now a landslide risk from slope above community due to the fires ; and
 - addressed 17 ESS calls to date this year, an increase from the average of one per month in prior years.

Advance planning and field assessments focused at flood risk management due to series of severe wind and rain events from Dec 18-20.

Plan and Guidelines:

- creating flood readiness checklist
 - 60% complete offered to emergency management staff for further input/feedback
 - creating Emergency Operations Centre (EOC) step by step orientation checklist to support personnel during activation
 - 80% complete Was provided to first group going through EOC functional workshop for feedback

- continue style guide and reformatting work on regional emergency program guidelines
 - 90% complete still need insertion of tools developed as per seasonal readiness and EOC training e.g. EOC Functions quick tips guides
