Highlights

Two initiatives that I have been closely involved with have both incorporated into Societies to better advance and continue their projects.

Executive members of both the Comox Valley Exhibition Society and the Comox Valley Farmers Institute have joined up to form the Comox Valley Agriplex Society with the hope of designing and building a large building that could accommodate both Agricultural and multi-use activities possibly on the present Comox Valley Exhibition site. The other is the Forbidden Plateau Reclamation Society. This Society's goal is the reclamation and remediation of the abandon ski hill site on Wood Mountain. After almost four years of wrangling with various provincial ministries (it is never easy), the group finally got the permission to start some work in the fall of 2017. They are actively seeking funding opportunities from both private and public bodies in hope of continuing the work in 2018. The goal of the society is strictly to repair the environmental damage at the site. They have absolutely no long term plans concerning developing or usage for the park.

Cumberland "Maple Lake" park committee, after over two years, dissolved when the Lake was sold to a private company. Although some funding from a few large conservancy groups looked promising, the money was contingent on having multiple parties on the title and the covenants but the Village was not willing to "partner".

Mt. Washington Fire Service moves closer to reality with building of the new fire hall set for late 2018. It was announced that Oyster River Fire and Rescue have the interim contract.

After being involved with the Courtenay July 1st Committee for 25 years (19 as Chair), the City has decided to take on the Canada Day Celebrations with staff looking after the organization and the logistics of what is now an over \$60,000.00 event. Liability issues and new and more stringent regulations have put these kinds of community events well beyond the abilities and time commitments of volunteers. I thank all my Committee members and wish the City the best for the future.

Probably the longest running of all Area "C" files relates to achieving proper zoning for the "Courtenay and District Fish and Game Protective Association." Multiple concerns raised by Provincial agencies and adjoining municipalities over the non-compliant nature of the facility resulted in a lot of hard work by both the Association and Comox Valley Regional District staff. The final bylaw went to public hearing in December 2017. Big salute to all who worked through all the hurdles to make this a long awaited success. Bravo!
