SAFEHAVEN:

Refugee Sponsorship Group

Early in 2016, a few members from two Comox Valley Churches were talking about the refugee tragedy that was dominating the headlines around the world: from that conversation grew the plan to sponsor 1 or more families to come to our beautiful Comox Valley. That group is now called Safehaven: Refugee Sponsorship Group and the group is working through the government-approved Sponsorship Agreement Holder, the Intercultural Association of Greater Victoria (ICA). You can view their history, mandate and structure at their detailed website icavictoria.org.

We have a bank account at the Coastal Community Credit Union with 3 Trustees. The account is stand alone, transparent and auditable. To date we have raised approximately \$65,000.00 and will continue to fundraise issuing tax receipts when requested.

We have an online refugee donation link established on St. George's United website at stgeorgesunited.com and we now have a Facebook page under Safehaven: Refugee Sponsorship Group with a donation link. We will be sponsoring several fundraisers over the next 6 months so please watch the newspapers

ESTIMATED BUDGET*

We have entered into a contractual agreement with the ICA to sponsor a Syrian family of 7 who are "sheltering" in Turkey. The family is composed of a widowed Mother with 4 children (ages 12,10,8, and 4) and the grandparents 63 and 70. The below budget reflects the size of this family. To show their commitment, the ICA is supporting our fundraising effort with a contribution of \$5,000.00 and we are truly grateful.

The Safehaven Team consists of 18 ordinary Comox Valley residents who have agreed to be part of an extraordinary event, the rescue of this family who fled during the Syrian civil war from northern Syria.

For a refugee family of 7 – for a period of one year, the budget provides a very rough estimate, with many built-in assumptions. Assumptions include that all furnishings, appliances, phones and computers as well as some clothing will be donated.

*** The Canadian Gov't bills refugees for air flights. This bill can be as high as \$15,000. The balance after the \$5,500.00 above will come from any overage we receive above the budget total.*
