Purpose

RE:

To provide the Committee of the Whole with the proposed 2020 - 2024 Financial Plan and work plan highlights for the Search and Rescue Service, function 265.

2020 - 2024 Financial Plan - Search and Rescue Service - Function 265

Recommendation from the Chief Administrative Officer:

THAT the proposed 2020 – 2024 financial plan for the Search and Rescue service function 265 be approved.

Executive Summary

The five search and rescue organizations funded under this function provide a valuable public safety service to residents and visitors to the Comox Valley. The organizations, staffed by volunteers, respond to incidents that include water safety, missing persons and motor vehicle accidents.

- The estimated residential tax rate for 2020 is \$0.0066 per \$1,000/assessed value compared to \$0.0063 in 2019.
- The maximum requisition for the service is \$0.03 per \$1,000 of assessed property value resulting in a maximum levy in 2020 of \$525,699.
- The 2020 tax requisition is increased \$13,547 over 2019 due to a one time canopy request from Comox Valley Ground Search and Rescue and increased operation funding for Comox Rescue #36.
- Operating expenses have increased \$9,900 compared to the adopted 2019 financial plan for 2020 due to a slight increase for Comox rescue vehicle #36 and a one-time grant to partner on support of an outdoor vehicle canopy for Comox Valley Ground Search and Rescue.
- There are no reserve funds associated with this service.
- Consideration of options for a new facility location for Comox Valley Ground Search and Rescue will be a work plan highlight.

Financial Plan Overview

The 2020 - 2024 proposed five-year financial plan for Comox Valley Search and Rescue service, function 265, including service establishment information, the requisition summary and the operating is available within the full proposed budget binder, provided in both searchable PDF and e-reader formats, located on the CVRD financial plan web page at www.comoxvalleyrd.ca/currentbudget.

Table 2 summarizes the 2020 proposed budget as compared to the 2019 adopted budget. Significant variances from 2019 adopted budget will be discussed in the financial plan sections that follow.

Highlights of the 2020 - 2024 proposed financial plan for function 265 include:

Revenue Sources

The proposed 2020 tax requisition is \$132,809; an increase of \$13,457 from 2019.

The allocation between the participants at this stage is as follows:

Personnel

There are no personnel costs allocated to this service which is under the portfolio of the General Manager of Community Services.

Operations

The operation line items are proposed to increase by \$9,910 over 2019. This is primarily due to increased funding request from Comox Rescue #36 and a one-time grant request to CV Ground Search and Rescue for a vehicle canopy cover.

Each organization funded by this service has capital equipment that they have acquired over the years through various funding mechanisms. This equipment is often specialized to undertake the search and rescue functions these organizations perform and therefore are expensive to purchase, operate and maintain. Periodically this equipment requires replacement due to age, use, legislative requirements and increased customer service. The replacement or upgrades of this equipment can lead to requests by the organizations for additional grant funding from the service. Table 3 outlines the grant recipients for the service and the operating grants requested for the proposed 2020 budget.

Capital

The CVRD does not own any capital associated with this service.

Reserves

There are no reserves for this service.

Tax Impacts

- Based on the 2020 completed assessment roll, the estimated residential tax rate for this service is expected to be \$0.006 per \$1,000 of taxable assessed value.
- The 2019 residential tax rate for the service was \$.0063 per \$1,000 of taxable assessed value.
- For a residence with an assessed value of \$500,000, the total tax impact is estimated to be \$3.30

Citizen/Public Relations

The various search and rescue organizations funded under this function provide a valuable public safety service to residents and visitors to the Comox Valley. These organizations were deployed to incidents that included water safety, missing persons and motor vehicle accidents. Many of these organizations are staffed by volunteers who have undertaken extensive specialized training in order to respond to search and rescue incidents. This service has operated successfully over the years and is sustainable.

Just got the formal quote in after I sent the last email so I have updated it.

Doug having talked to Howie regarding the information you require I hope this e-mail provides what you need.

1. Canopy: We have received a quote for a canopy that provides coverage for one of our field vehicles outside of our bays. We do not have enough room in our bays with the new R4 being housed inside. Our vehicles need to be ready to go on a moments notice, no warming or defrosting of the windshield for 5 - 10 minutes before we depart, 24x7.

The canopy needs to be a double unit and go adjacent to the sea cans because a) a single unit canopy will not fit beside the sea cans 2) if a single unit went at the opposite end of the parking area then any snow removal would have to be pushed together in front of the sea cans preventing access to them. The sea cans are used for storage for both CVEP and CVGSAR larger and/or seasonal items that are not able to be stored in the bays or upstairs in the mezzanine.

The canopy estimate is for an engineered designed structure that comes with specs for wind and snow loading ratings. The roof is metal of 26 gauge aluminum. It comes with a 25 year limited warranty on the metal sheeting and 20 year limited warranty on the structural galvanized framework.

Estimated price is \$6000 for the double canopy and any set up work to put up the temporary shelter.

2. Electronic Gate Access: The landlord agreed, as part of the new rental agreement, to provide at 50% his expense and 50% our expense (CVGSAR and CVEP - also 50% each as previously agreed to) an electronic side gate access. This would reduce the keys that we have to issue people (there are a lot of keys issued) and would allow us to monitor who is entering and exiting the gate. At night it would make it safer, due to increased speed in a partially dark alley, to access and exit the back parking lot.

This was supposed to be completed last fall, and again this year we have been hounding the landlord to install the electronic access unit.

Estimated total price was \$6,000 of which \$3000 was to be split equally between CVGSAR and CVEP.

Total cost of these 2 improvements: \$12,000 CVGSAR portion \$6000 + \$1500 = \$7,500 CVEP portion (gate) = \$1,500 Landlord for the gate = \$3,000

3. We use the grant from the CVRD to cover operational costs of the building, any capital costs are paid from our fundraised monies. We had not requested an increase to our grant because we did not have a firm estimate or approval from our Board on how to proceed at the time of the budget request. If the CVRD would be willing to help us out in 2020 to pay for these improvements, by an increase to our grant of 50% of the improvements, we would be truly grateful.
