# **Purpose**

To provide the Electoral Areas Services Committee with the proposed 2019 - 2023 Financial Plan and work plan highlights for the Electoral Areas Arts and Culture Grant Service, function 615.

## Recommendations from the Chief Administrative Officer:

- 1. THAT the proposed 2019 2023 financial plan for Electoral Areas Arts and Culture Grant Service Function 615 be approved.
- 2. THAT staff negotiate a one year term service agreement with the 2019 Electoral Areas Arts and Culture Grant recipients with an option of a one year renewal.
- 3. THAT staff bring forward a report in spring of 2019 to review the Electoral Areas Arts and Culture Grant service, function 615, with options of improving the service.

# **Executive Summary**

The service was established for the electoral areas to provide funding to societies and nonprofit organizations that own and/or operate arts or culture facilities in the Comox Valley to assist with the protection, preservation, maintenance and promotion of infrastructure.

- Proposed 2019 tax requisition is \$79,500 or \$0.0124 per \$1,000 of assessed value, an increase of \$6,289 over 2018;
- For a home assessed at \$400,000, this represents a residential tax levy in 2019 of \$4.96;
- 2019 maximum requisition is \$142,671 based on a maximum levy equal to the greater of \$100,000 or \$0.025 per \$1,000 of assessed value;
- Total grant allocations for 2019 are \$73,673 vs a total of \$72,150 in 2018;
- Most recent grant service agreements expired December 2018 and will require renewal in 2019;
- Staff will bring forward a report in the spring with recommendations to improve this service;
- Staff are recommending a two-per cent increase to grant recipients for 2019;
- Requests for increases to annual grant funds have been received from several of the recipient agencies which are not included in the proposed financial plan.

## **Policy Analysis**

The Electoral Areas Arts And Culture Grant Service is established by Bylaw No. 278 being "Electoral Areas Arts and Culture Grant Service Establishing Bylaw No. 278, 2014", for the purpose of providing funding to societies and nonprofit organizations that own and/or operate arts or culture facilities in the Comox Valley to assist with the protection, preservation, maintenance and promotion of said infrastructure.

- Maximum tax requisition: the greater of \$100,000 or \$0.025 per \$1,000 applied to the net taxable value of land and improvements for regional hospital district purposes.
- Participants: CVRD's Electoral Areas A (excluding Denman and Hornby Islands), B and C.

# Financial Plan Background and Overview

This electoral area service was created in 2014 to provide an annual contribution for various organizations that provides them and the regional district with greater financial certainty for a five year term. The money would be able to be used to assist with the protection, preservation, maintenance and promotion of the arts and culture facilities.

Most of the organizations participating in this service received incremental increases over the five year term of the service agreement which expired on December 31, 2018.

Staff are recommending a two-percent increase to grant recipients for 2019. This will allow time for staff to bring forward a report in the spring of 2019 with recommendations to the board for consideration to improve this service. If there are board adopted changes they could be implemented in the 2020 financial planning process.

Requests for increases to annual grant funds have been received from several of the recipients. These requested increases have not been included in the proposed financial plan.

Table1 summarizes the 2019 proposed budget as compared to the 2018 adopted budget. Significant variances from 2018 adopted budget will be discussed in the financial plan highlights section below.

Highlights of the 2019 - 2023 proposed financial plan for the service include:

### Revenue Sources

The proposed 2019 tax requisition is \$79,500 representing an increase of \$6,289 over 2018. This increase is due to two per cent increase in operational grants budgeted in 2019.

#### Personnel

No personnel associated with this service.

### Operations

The increase in operational costs to \$80,554 in 2019 is reflective of the two per cent increase applied to all recipient organizations except \*Comox Archives & Museum who have indicated they were not seeking an increase to their funding. (See Table 2 below).

## Capital

There are no capital costs associated with this service.

#### Reserves

There is a future expenditure reserve with a balance of \$17,425 as of December 31, 2018. There is a reserve contribution of \$4,976 proposed for 2019. Reserve balances will be confirmed and updated as part of the recommended budget once the 2018 year end is closed.

## Citizen/Public Relations

Stakeholder engagement has begun with some of the recipients and staff will continue to seek feedback from the remaining grant recipients currently funded under this service. This feedback will be used for incorporation into the report back to the board in the spring of 2019.
