PROPOSED TELECOMMUNICATIONS TOWER – 3505 DOVE CREEK ROAD - TELUS COMMUNICATIONS INC.

D. Thiessen, Planner, provided an overview of the memorandum dated September 23, 2021 regarding the construction of a 62.0 metre tall telecommunications tower on the property located at 3505 Dove Creek Road.

Brian Gregg (SitePath Consulting Ltd.) representing Telus, was in attendance via electronic means.
