<u>REPORTS</u> LETTER OF CONCURRENCE REQUEST – 3301 MACAULAY ROAD (TELUS COMMUNICATIONS)

D. Thiessen, Planner, provided a memorandum dated March 24, 2021 regarding a request from SitePath Consulting Ltd., acting on behalf of TELUS Communications, for a Letter of Concurrence from the Comox Valley Regional District for a 48.1 metre tall telecommunications tower on the property located at 3301 Macaulay Road.
