RE:	Fire and Rescue Services Agreement – Mutual Aid		

### Purpose

The purpose of this report is to seek Board endorsement to extend the current fire and rescue services mutual aid agreement allowing Comox Valley Regional District (CVRD) fire departments to request assistance, or respond to requests for assistance from other local fire departments on a cost recovery basis. Further to update the Committee regarding the mutual aid agreement with Canadian Forces Base Comox (CFB Comox).

# Recommendation from the Chief Administrative Officer:

THAT the Board approve the extension and amendment of the current Fire and Rescue Services Mutual Aid Agreement with the City of Campbell River, City of Courtenay, Town of Comox, Village of Cumberland, Union Bay Improvement District, and the Ships Point Improvement District, for a five-year term (May 10, 2018 – May 10, 2023), as outlined in staff report dated June 11, 2018.

AND FINALLY THAT the Chair and Corporate Legislative Officer be authorized to execute the agreement.

# **Executive Summary**

- The term of the current agreement is May 10, 2018 and remains in effect on a month-tomonth basis.
- Legal counsel and Municipal Insurance Association have reviewed the agreement.
- An agreement to extend and amend the current mutual aid agreement has been developed.
- Update: The mutual aid agreement with CFB Comox will expire in June 2019.
- A renewed agreement with CFB Comox is currently being developed by the Department of National Defence (DND) and will be the subject of a future staff report.

## **Background/Current Situation**

Comox Valley fire and rescue services agreement

In May of 2007, the CVRD joined other fire and rescue service providers in endorsing the Comox Valley Fire and Rescue Services agreement which provides for the ability of fire departments to legally and promptly access the resources of other fire departments should they be needed and available. Since inception, this agreement has been proven a valuable tool for mutual aid assistance between the fire departments. The term of the current agreement is May 10, 2018 and remains in effect on a month-to-month basis.

In discussions with the membership of the Comox Valley Fire Chiefs Association, staff has developed amendments that update the agreement to reflect current reimbursement rates, as determined by the Province.

Legal counsel assisted in the development of an agreement to extend and amend the current mutual aid agreement (attached as Appendix A).

### Update: Mutual aid agreement - Canadian Forces Base Comox

In May of 2014, the CVRD signed the Memorandum of Understanding with the DND and other fire and rescue service providers which provides for the ability of fire departments to legally and promptly access resources of CFB Comox should they be needed and available. Since that time, this agreement has been a valuable tool for mutual aid assistance. The current agreement expires in June of 2019

DND is currently developing a renewed agreement which will be the subject of a future staff report

### **Policy Analysis**

The Local Government Act, (RS2015) - Sections 263 and 697 empower the regional district to enter into mutual aid agreements with other jurisdictions.

The CVRD provides fire protection services by way of the following bylaws:

- Denman Island, Bylaw No. 2105
- Hornby Island, Bylaw No. 2012
- Fanny Bay, Bylaw No. 416
- Black Creek/Oyster Bay, Bylaw No. 176

The regulatory bylaws for the CVRD fire protection services above include a "Cost recovery fees and charges for extraordinary fires" component. Under this section of the bylaws the CVRD may recover costs from the property owner where an extraordinary fire has occurred.

At its regular meeting of March 26, 2013 the board endorsed the CVRD entering into a fire and rescue services agreement with other local government fire protection service providers.

### Staff Report - Fire and Rescue Services Agreement - Mutual Aid

### Options

The options available to the board include:

- 1. Endorse the extension and amendment of the mutual aid agreement.
- 2. Request further information.
- 3. Not endorse the extension and amendment of the mutual aid agreements.

This staff report provides information in support of option 1

# **Financial Factors**

As the mutual aid agreement includes a "cost recovery" component, it is possible that a request for assistance may impact the operational budget of a requesting fire department. This aspect is mitigated by the regulatory bylaw component that authorizes the CVRD to recover mutual aid costs associated with an extraordinary fire. Further, past records indicate that this is a very rare occurrence.

# Legal Factors

In 2006, the development of the first mutual aid agreements included a review by legal counsel as well as a review by the Municipal Insurance Association (MIA).

In 2018, the agreement was again reviewed by legal counsel and MIA to confirm that past advice is still relevant. Both MIA and legal counsel have provided their opinion. Legal counsel assisted in the development of an agreement to extend and amend the current agreement

# **Regional Growth Strategy Implications**

Objective 7C of the Regional Growth Strategy is to improve regional fire safety. The recommendations of this report support that objective.

# **Intergovernmental Factors**

If approved, the renewed mutual aid agreements will facilitate the continued efficiencies of working with other local governments, improvement districts, CFB Comox and their respective fire departments, in providing an enhanced fire protection service.

# Interdepartmental Involvement

Community services and financial services staff worked collaboratively to develop the renewed Comox Valley fire and rescue services agreement.

# **Citizen/Public Relations**

If approved, the renewed implementation of the two fire service mutual aid agreements with neighbouring jurisdictions will provide the citizens of the CVRD with an enhanced fire protection service.

Emergency Resource reimbursement rates are as per the Province of BC document "Inter-Agency Operational Procedures and Reimbursement Rates" as amended from time to time.

### Specialized Emergency Resource reimbursement rates are as follows:

Fireboat with a minimum of two firefighters	\$495.00 /hour
Hazmat "B" trailer, tow vehicle & four firefighters	\$440.00/hour
Hazmat Special Operations Apparatus "Level A"	At rate of Structural Engine-Type 1
