Purpose

To provide information with respect to the 2018 parcel tax roll review panel and to appoint the directors to the panel for authentication of the roll.

Recommendation from the Chief Administrative Officer:

THAT a parcel tax roll review panel be held at 9:30 a.m. on February 21 2018 to authenticate the 2018 parcel and frontage tax roll and that Directors Jolliffe, Nichol and Grieve, Comox Valley Regional District directors representing Electoral Areas A, B, C, and Director Leigh, Strathcona Regional District director representing Electoral Area D for the Black Creek/Oyster Bay water service area, be appointed to the panel.

Executive Summary

Parcel taxes are levied in several local service areas in the Comox Valley Regional District (CVRD) in accordance with the applicable bylaws. As well as several service areas in the CVRD, the CVRD also levies parcel taxes in the Black Creek/Oyster Bay water local service area that has properties located in both the CVRD and the Strathcona Regional District. A parcel tax roll review panel, comprised of a minimum of three members, is a requirement of the *Community Charter*. The panel sits in February each year to provide an opportunity for residents to appeal their parcel tax assessment and to authenticate the parcel and frontage tax roll. Electoral area directors are appointed to the panel at the inaugural meeting each fall.

Background / Current Situation

The CVRD has several local service areas in which a bylaw has been passed providing for the collection of a parcel or frontage tax to assist in the costs of providing the service. Each year, a parcel tax roll review panel sits to consider and authenticate the roll which has been prepared by CVRD staff. Below is a list of the local service areas in which a parcel tax is levied by taxable frontage, taxable area or per parcel and the associated rates in effect at the time of this report. Adjustments to these rates may be recommended through the 2018-2022 financial planning process in early 2018 and would require a bylaw amendment. Staff plan to present the Sandwick water local service area parcel tax bylaw in November with final adoption targeted by January 2018.

In compliance with the *Community Charter*, the parcel tax roll review panel notice is advertised in the local papers and small rural publications in order that residents have an opportunity to review the rolls and submit an appeal regarding their parcel tax assessment.

Policy Analysis

Under section 388 (2) of the *Local Government Act* [RSBC 2015, c.1] (LGA), if a parcel tax is to be imposed the board must, by bylaw, provide for the preparation of a parcel tax roll for the service area, and for these purposes Division 4 [Parcel Taxes] of Part 7 of the Community Charter applies.

Section 204 of the *Community Charter* requires that a parcel tax review panel be formed to hear any complaints respecting the parcel tax roll and must authenticate the roll.

Citizen/Public Relations

Letters are sent to all residents who have shown a change on the parcel tax roll from the previous year, to ensure they are aware of the parcel tax assessment and their opportunity for appeal. This, combined with website information and a publicized notice in the local newspapers, ensures the public is informed about the process. Copies of the rolls for the various service areas are published on the CVRD website as well as in hard copy which are available for viewing in the CVRD administration office.
