### Purpose

2021 Rural Community Grant Considerations - September 2021 Intake

#### Recommendations from the Deputy Chief Administrative Officer:

1. THAT the 2021 Rural Community Grants be awarded for the amounts to the organizations as follows:

AND FURTHER THAT consideration be given to the potential establishment or inclusion of Hornby Island in an affordable housing service to be initiated with a letter to Islands Trust to review options and jurisdictional considerations.

#### **Executive Summary**

- The Comox Valley Regional District completed a review of all its grant funding programs and services in 2020 in an effort to standardize processes, establish more formalized criteria and ensure increased transparency and clarity to both the public and any non-profit organizations seeking or receiving funding.
- The RCG program was launched in January 2021; any non-profit community organization may apply for funding that benefits the general community.
- In April 2021 the board awarded a significant portion of the RCG funding by considering RCG applications received to the end of March 2021.
- Additional applications received since August 2021 are listed in Appendix A for consideration.
- RCG applicants will receive written notice on the status of their funding request once the Elector Area Directors have met and completed their adjudication and funding allocations and following board approval.
- Funding awards will be dispersed after August 1, 2021, unless otherwise stipulated.
- Electoral Areas Services Committee (EASC) members are asked to review the attached listing of submissions and advise of their funding commitment.

Of particular interest is the request from Hornby Housing Society for septic upgrades. This application is similar to Denman Island Housing Association funding options considered by the EASC in April 2021 (<u>Dyson SR Denman Affordable Housing Funding Options</u>). The EASC concluded:

THAT the funding request from the Denman Island Housing Association to assist with predevelopment costs for the Denman Green affordable housing project not be supported;

AND FURTHER THAT consideration be given to the potential establishment or inclusion of Denman Island in an affordable housing service to be initiated with a letter to Islands Trust to review options and jurisdictional considerations.
