## Purpose

To advise the Electoral Areas Services Committee (EASC) of a request from the Hornby Island Residents' and Ratepayers' Association (HIRRA) that the Comox Valley Regional District (CVRD) work with HIRRA, and the Denman Island Residents' and Ratepayers' Association (DIRRA) to undertake an Animal Control Bylaw feasibility study for Hornby Island and Denman Island in 2021.

### Recommendation from the Chief Administrative Officer:

THAT a feasibility study be conducted to explore options and costs associated with animal control services on Hornby Island and Denman Island in 2021;

AND FURTHER THAT \$12,000 be included in the proposed 2021 – 2025 Financial Plan to be funded by both the Hornby Island Feasibility Study Fund, Function 155, and the Denman Island Feasibility Study Fund, Function 154.

## **Executive Summary**

- Formal request received from HIRRA advising that DIRRA has agreed that Denman Island should participate in the proposed 2021 Animal Control feasibility study.
- Conducting a joint study of a shared animal control service, will provide options that would mutually benefit both Hornby and Denman islands.
- Study costs budgeted at \$12,000 and allocated at 50 per cent to Functions 155 and 154 respectively.

## **Background**

The CVRD received a formal request from HIRRA dated January 9, 2020 requesting that the CVRD work with HIRRA and the Hornby Island community to undertake an Animal Control Bylaw feasibility study. The Comox Valley Regional District Animal Control Service was established in 1981 with the service area covering Areas B, C, and the Vancouver Island portion of Area A. Currently there is no animal control service for Hornby or Denman islands.

At the March 9, 2020 Electoral Areas Services Committee a staff report was presented, to advise the Committee of the correspondence received from HIRRA to have the CVRD undertake an Animal Control feasibility study in 2021. The recommendation from that report was:

"THAT the Hornby Island Residents' and Ratepayers' Association and the Denman Island Residents' and Ratepayers' Association consider making a joint request that the Comox Valley Regional District undertake an Animal Control Feasibility study for both Hornby and Denman Islands in 2021."

On September 24, 2020 the CVRD received correspondence from HIRRA advising that DIRRA has agreed that Denman Island should participate in the proposed Animal Control feasibility study. The letter of request from HIRRA is attached as Appendix A of this report.

Conducting a joint study with cost sharing and the exploration of a shared animal control service, will provide information and options that would mutually benefit both Hornby and Denman islands. A feasibility study conducted for both Hornby and Denman islands would be budgeted at \$12,000 and allocated at 50 per cent to Functions 155 and 154 respectively.

This study would start in spring of 2021 and would involve bylaw and communication staff time with the assistance of a local consultant, who would lead a public consultation process including but not limited to the use of a dedicated webpage, online surveys, and public information sessions.

An overview of the steps to establishing an Animal Control Service for Hornby and/or Denman islands is attached as Appendix B of this report.

#### **Options**

- To consider a joint Animal Control feasibility study for Denman and Hornby islands in the 2021 budget.
- 2. To not proceed with a joint Animal Control feasibility study.

This report supports Option 1, with the CVRD undertaking a joint Animal Control Feasibility study for both Hornby and Denman Islands in 2021.

In January 2020, at the direction of our membership, HIRRA requested that the CVRD undertake an animal control bylaw feasibility study for Hornby Island. We received a response from Jake Martens that recommended we bring forward a request for a joint feasibility study with Denman for 2021.

The Denman Island Residents Association president, Ron Shepherd, informed me by email (Sept. 8, 2020) that he DIRA Board of Directors met on September 7, 2020, and agreed that Denman Island should participate in the proposed Animal Control Feasibility Study.

Currently there is no animal control bylaw on Hornby or Denman and residents of both islands have expressed concerns about animals at large.

Therefore, we respectfully request that the CVRD work with HIRRA, DIRA and our island communities to undertake an Animal Control Bylaw feasibility study in 2021.

### Steps to Establishing an Animal Control Service for Denman and/or Hornby Islands

This document gives a brief overview of the legislative process to establishing an animal control service for Denman Island or for Hornby Island. The benefits to establishing such a service include public access to trained animal control personnel, reactive and proactive investigations and patrol, promotion of responsible pet ownership and humane treatment of animals and if required dangerous dog management.

The alternative is for property owners to continue to rely on the RCMP to provide this service. In certain cases involving wildlife or dogs chasing wildlife then B.C. conservation officers will assist, however resources with both of these agencies are limited and therefore only when public safety is jeopardized or injuries have occurred would these agencies investigate.

Step 1 Reise idea

- •The idea for an animal control service can be raised by regional district directors, Islands Trust, either Hornby or Denman Island residents or community associations or by staff
- •As regional districts establish and provide services in direct response to expressed needs, a key point is that the service's benefiting area determines both who receives the service and who pays for it

Sitep 2

- The study would include items such as:
- Clear and understood purpose of the proposed service
- Defined and agreed upon scope
- Cost sharing among the parties
- Access to kenneling for this service
- · Service delivery
- · Service governance

Step 3 evelop bylaw

- If the service is deemed feasible, a service establishing bylaw would be developed
- •An unweighted corporate vote at the CVRD board table is held (every director present must vote and is given one vote) with a majority determining the outcome

Step 4 Ministry and lector consent

- After third reading, the bylaw must receive approval from the inspector of municipalities and the approval of the area(s) that are are intending to participate in the service
- Electoral approval can be obtained by an alternate approval process or referendum

Step 5 Adopt bylaw • Once the bylaw recieves inspector and elector approval, it can be adopted by the board
