Advisory comments:

Members expressed concern that there hasn't been sufficient time to extensively review the proposed bylaw. The staff report will be brought back to the July 2, 2020 Sewage Management Advisory Committee before proceeding to the Sewage Commission.

Clarification was provided regarding the term "non-regulatory bylaw". This proposed bylaw is not related to the K'ómoks First Nation (KFN) Memorandum of Understanding (MOU) and has been created as a result from the February 11, 2020 Sewage Commission meeting resolution which states

"AND FURTHER THAT staff present a new bylaw to guide the future decision process for the Comox Valley Sewage Commission and Comox Valley Regional District with respect to the planned system expansion based on criteria that relates to finances, decision-making and historic roles, authorities and investments;"

The bylaw is described as non-regulatory because it doesn't convey an ability to ticket, set rates or fees and acts as more of a policy measure than a regulatory one. This is being written as a bylaw because it then carries more weight to rely on going forward.

Draft staff report: CFB Pump Station Upgrade Budget Amendment

Letter dated March 12, 2020 from Wendel Lamb Re: Request for a Recreational Vehicle Sani-Dump Site

There is no intention to bring a report forward to Sewage Commission at this time, but the letter will be on the next Sewage Commission agenda for discussion.

A brief discussion took place over whether a sani-dump service should be provided by the Comox Valley Regional District (CVRD) or a member municipality. Preliminary thoughts are that it would be more appropriate to be a CVRD service as it's a regional benefit (example: bulk water fill station). That approach would likely require partnership with the municipalities to tie into the sewer system (similar to the operation of the bulk water fill station).
